SPEAKER BIOGRAPHY

方頌仁博士 (Dr. Simon Fang), 達盈管理顧問公司合夥人

方頌仁先生於 1996 年獲得美國史丹佛大學材料系碩士與博士學位,並服務於美國德州儀器公司(Texas Instruments)研發部門,從事半導體先進製造技術之開發。1999 年返台加入聯華電子,先後在研發部門、客戶服務工程部與新事業發展部等部門任職,並於 2003 年擔任銷售副總,派往美國聯電負責北美業務。期間方頌仁曾發表 30 餘篇技術論文,並獲得 2 項美國專利。2006 年成



為 AsiaTech 創投基金台北辦公室合夥人,專注於新創公司的早期投資,主要投資項目為 半導體、通訊、消費性電子及安全監控等相關產業。2008 年 8 月與王耀庭博士共同創立 達盈科技管理顧問公司,專注於創投基金之管理及新創事業之諮詢服務,目前已投資超過 四十家新創公司。

After graduating from Stanford, Fang joined Texas Instruments to develop advanced semiconductor processing technologies. In 1999, Fang joined United Microelectronic Corporation (UMC). He has been with UMC's various divisions including R&D, Customer Engineering, and New Business Group. In 2006, Fang joined AsiaTech Venture as Technology Partner. In August 2008, Fang and Dr. Yaoting Wang co-founded Darwin Management, Inc.
